

ESEARCH INTO THE SCALE AND COSTS OF OCCUPATIONAL STRESS

The Health and Safety Executive wishes to sponsor research to determine more clearly the scale of stress caused or made worse by work, the actual ill-health effects and the real cost to industry, both nationally and in relation to different sectors and occupations.

Applications are sought from research workers in Universities or equivalent organisations for research projects lasting up to 3 years. The proposers, who must demonstrate previous successful research performance, should have access to multi-disciplinary expertise in the fields of occupational medicine (in particular occupational stress), epidemiology, statistics and economics.
